Description of the Type Design Change: Modify Crankcase, Crankshaft, Carburetor and install Cylinders from 520 cubic inch displacement engine and revise operating limits as shown in addendum SE2107NM. This is in accordance with Kenmore Air Harbor, Inc. Report No. 13008, Rev. 1, dated July 9, 1998, or later FAA approved revisions.

NOTE: This engine modification is limited to installation in the Cessna 180G, 180H, 180J, and 180K aircraft only.

Limitations and Conditions: Approval of this change in type design applies to the above model engines only. This approval should not be extended to other engines of this model on which other previously approved modifications are incorporated unless it is determined that the relationship between this change and any of those other previously approved modifications, including changes in type design, will introduce no adverse effect upon the airworthiness of that engine. A copy of this Certificate, and Addendum, amended March 1, 1999, or later FAA approved revision, must be maintained as part of the permanent records for the modified engine.
